Causeway Flooding at Issue

The Fire District will be going out with a Request for Proposal to find a consultant to conduct field investigations and explore engineering alternatives for the ongoing flooding issues of Wesquage Pond at Bonnet Point Road both on the causeway and at the breach-way. Issues that will be addressed is the current situation of culverts, barriers and channels within and adjacent to Bonnet Point Road. This study will focus on a

limited topographic survey, and a hydrologic and hydraulic drainage analysis as a means to develop alternatives for mitigating flood conditions. It will provide and overall picture of where we are, identify problem areas and causes, and present methods, options and anticipated costs estimates that the district could consider to help alleviate the flooding conditions and ensure the integrity of the road.

Time to Hit the Beach

Finally, summer has arrived in Bonnet Shores! Lifeguards will be at their stations when the beach officially opens on Saturday, June 25th. You'll find lifeguards on duty at Kelly Beach from 10 a.m. to 5 p.m. Monday through Friday, and from 10 a.m. to 5:30 p.m. on Sundays.

Beachgoers will find a few enhancements to the beach area this summer, including a new ramp at the end of the Dunes Road walkway. There have also been repairs and upgrades made to the footbath and to various benches built into the walkway.

No lifeguard coverage will be available at Little Beach this summer. However, dedicated resources will be committed to cleaning the area on a regular schedule, including removing and carting away seaweed which accumulates on the beach from time to time.

As always, beach committee chairwoman Janice McClanahan invites all Bonnet residents to weigh-in on ways to enhance the beach experience.

Road Work Planned

The Road Committee recently announced upcoming road work in Bonnet Shores. Three streets -- King Philip, What Cheer and Onondega – are scheduled to be resurfaced either late in the fall of this year or in the Spring of 2017. Work will include improvements to the drainage system in the northern section of Bonnet, including the retention area located near the intersection of Spring Brook and Bonnet Shores Roads.

Given the fiscal constraints on public works budgets across Rhode Island's 39 cities and towns, the Fire District Council was pleased to learn of road improvement plans for the next 6-9 months. Council members and District Manager Lisa DiBello continue to stay in close contact with Narragansett's Public Works Department to ensure that scheduled and budgeted work is completed within the stated timeframes.

The Bonnet Shores Land Trust objectives can be summed up as follows:

- Protecting and preserving open space and recreational areas in the community
- Strategic acquisition of land that furthers that goal
- Long range planning to maximize the use of community land for recreational and historic preservation
- Fund raising activities to support these efforts
- Encouragement of volunteer efforts by joining in Land Trust activities

To these ends, Trustees have engaged over the past year in discussions with Roger Williams University, CPC to bring them to the community this fall to assess and recommend potential and innovative uses for community property.

The Land Trust reports the strategic acquisition of property on Wesquage Pond by way of a generous gift from the estate of Kathryn Davidson. The family of Manuel Torti, long time Bonnet resident, has also

graciously donated land to the Trust in honor of Mr. Torti. Both of these gifts speak volumes about the love of Bonnet Shores the deceased shared with all of us.
